HSGC – Executive Council

Meeting Minutes– March 6, 2011

Present: Krutarth Jain(President), Ambikaipakan Balasubramaniam (Vice President), Deepak Dixit (Secretary), Prasad Megada (Treasurer), Kiran Dayal (Pooja Committee), Laxmi Srivastava (Long Range Planning), Anisha Singh (Religious Education Committee), Raneshwar Gupta (Fundraising Committee), Dilip Patel (Maintenance Committee)

Additional Attendees: Swarna Choudhary (Co-chair, Pooja Committee)

Absent: Geeta Mehan (Editor – Aradhana)

Minutes:

- 1.Ramesh Dayal and Laxmi Srivastava received EC approval for publishing color photos of the Garbha Griha and the Marg project, respectively.
- 2.The EC agreed to review salary structure of the priests. A special EC meeting will be held on March 20th to discuss it further.
- 3.The EC has agreed to create a Vedic library in the temple. Dr Pappu of Miami University has offered to donate his collection of books to the temple. He is also providing seed money to start this library, which will be started in his late wife's name. The temple will obtain a professional drawing and associated cost estimate for this project.
- 4.The temple is placing a lot of emphasis on providing additional community services. Towards this, the following services are being considered or are being offered:
 - A..The temple is planning to start a religious counseling service. It will be provided by respected scholars in our community. Initially, it will consist of Dr Pappu and Koti Srikrishna.
 - B.Geeta Mehan is providing counseling for women facing abuse or violence in collaboration with AIW/YWCA. Some additional guidelines need to be developed to handle such situations.
- 5.The EC also decided that each committee will be responsible for maintaining its own income and expenses.
- 6.Expense approvals:
 - A. EC members can spend up to \$1,500 without prior EC or president's approval.
 - B. Only emergency / maintenance expenses do not need pre-approval. An example of this is the recent installation of garbage disposal.
 - C. In the future, all projects will have clear specifications, clear bids, and a thorough evaluation by the chairperson of the specific project.
 - D. The supplies inventory will be tracked from now on.
 - E. The Pooja committee will also update inventory of all items including precious metals.
7. The EC also looked at ways to contain costs. Some of the items considered are:
 - A. Stop mailing of birthday and anniversary cards
 - B. Get advertisement for the calendar and consider printing on lower quality paper
 - C. Reconsider Patron's Day as it incurs a substantial cost
 - D. Manage the cost of flowers by considering local suppliers and/or collect monies from the sponsors. However, the cost of the flowers has been found to be fully funded.
 - E. Reduce expenses associated with Diwali sweets
 - F.. Raneshwar Gupta will look into the health insurance costs
8. Consider raffles for additional fund raising. Raneshwar Gupta will present more ideas in this respect in next EC meeting.
9. A policy will be created to provide and articulate benefits of HSGC membership.
10. The EC has decided to publish the special accounts once every 6 months or on an as-needed basis.
11. For the Marg project, the area is being surveyed. It will be cleared and soil will be tested for construction.
12. There are plans to use the Yagya Shala as a regional marriage center. A special activity chairperson may be named, who will be responsible for creating booklets, mailing for the Yagya Shala and marriage center. Raj Bodalia has been proposed as the chairperson for this center.
- 13.It has been proposed that a wellness center be established in the temple. Dr Hari Haran, who visited the temple last year, will be back in the temple on May 11. He will conduct 3-4 lectures and session on managing diabetes and blood pressure. It will be part of the wellness center initiative.
14. A separate unit in the basement will created that will help in conducting the yoga center as well as other activities such as children's activities, library, meditation, and wellness center.
15. Co-chairs for all committees will be named.
16. Major events will be given displayed prominently in Aradhana provided details of such events are provided for publication two months in advance.
17. Every committee will document their processes. The processes will get compiled in a handbook for the benefit of future committees.

18. Besides the subcommittee documentation, policies will be created for general areas such as evacuation, fire and burglary, permissions etc.
19. Congresswoman Jean Schmidt will be invited to the temple to help her understand our beliefs and practices. The tentative dates of her visit are March 6th or 13th or April 3rd.
20. Our priest Srinath ji recently received his green card. His family will join him soon.
21. YWCA/AIW – This organization helps women in various ways. Geeta Mehan is HSGC's liaison with this organization. So far, we have helped 6 cases of domestic violence from our community. Under this program, we have also provided assistance in the form of jobs assistance.
22. Two new major functions are being added to the temple calendar starting this year. These new major events in the temple are Lohdi and Bhajan Sandhya.
23. The temple website will be cleaned up. We will try to get paid advertisements for the website. The website will also be checked for correctness of information.
24. A pay committee has been constituted to look into the overall salary structure as well as roles and responsibilities.
