Concept of Trinity in Hindu Dharma

Brahma-Vishnu-Mahesh (Shiva) symbolize the Hindu trinity, also called the **Trimūrti** (**Sanskrit**: त्रिमूर्ति *trimūrti*, "three forms") The Supreme Divinity or Universal Truth, called *Param Brahman*, is represented in three forms, each corresponding to one cosmic function: Brahma (the creator), Vishnu (the preserver) and Shiva (the transformer/destroyer).

Because Hinduism is a collection of different traditions and beliefs, scholars believe Brahma-Vishnu-Mahesh was an attempt to reconcile the doctrine of Param Brahman with different approaches to the Divine.

Today, Brahma-Vishnu-Mahesh as the Trimurti is rarely worshiped. Instead, Hindus typically worship one of the three as the supreme deity, and consider the others as incarnations of their supreme god. For example, Vaishnavism holds that Vishnu is the supreme god, while Shaivism believes that Shiva is supreme. Brahma, in comparison, has relatively few devotees as the supreme deity.

In ancient texts, these three gods symbolize earth, water and fire:

- Brahma represents earth. He is the originating power and creator of all life. There are many stories about his creation. One of them is Brahma is the son of Param Brahman, while another belief is Brahma created himself from water and seed.
- Vishnu represents water, which symbolizes his role as the sustainer of life. He is the protector side of supreme being, known for upholding goodness and creation He has been

identified and worshiped the most with his incarnations; Lord Krishna and Lord Rama.

Shiva represents fire and is identified as the destructive power of the Trimurti; as a positive force that cleanses and destroys evil, paving the way for new creation. Shiva has a special place in the yogic traditions as he is considered the first yogi, or *adiyogi*. He symbolizes the balancing of awareness and bliss, and the calming effects of yoga practices in general.

The identification of Brahma, Vishnu and Shiva as one supreme being; is strongly emphasized in the *Kūrma Purāṇa*, where Param Brahman is worshipped as Trimurti, the unity of three personifications. In Gita (Chapter 10 Shloka 32) Krishna refers to this concept stating, "Of all creations I am the beginning and the end and also the middle, O Arjuna" This means that I, the Supreme Lord, am the creator, maintainer and destroyer.

Gita Shloka: sargāṇām ādih antaś ca, madhyam caivāham arjuna

sargāṇām — of all creations; ādih — the beginning; antaḥ — end; ca — and; madhyam — middle; ca — also; eva — certainly; aham — I am; arjuna — O Arjuna;

AUM 'ॐ'. itself is single syllable and considered as representation of Param Brahman! In AUM sound, Brahma is a creator (A of AUM), Vishnu as protector (U of AUM) and Shiva for dissolution (U of AUM). Thus, the Trinity is aspects of one and only, *Param Brahman*.

Significance of Lohri

Lohri is an agricultural festival, filled with merry-making. It is celebrated in the state of Punjab on the 13th of January, which falls one day before Makar Sankranti. Lohri is celebrated to denote the last day of the coldest days of winter. The festival of Lohri is celebrated outdoors, a bonfire is lit, and friends and relatives gather around. Singing and dancing form an intrinsic part of the celebrations. People wear their brightest clothes and come to dance the *bhangra* and *gidda* to the beat of the *dhol*. The prasad comprises of five main things: til, gazak, gur, moongphali (peanuts), and phuliya or popcorn. An offering is also made of this Prasad to the sacred fire. Lohri is celebrated throughout the country in different forms, as a harvest festival. It is called Pongal in the South, Bhugali Bihu in Assam, Bhogi in Andhra Pradesh and Sankranti in the central part of the country.

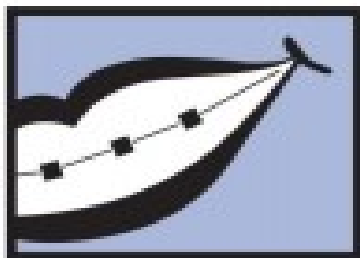
